#### **LEAVING NORMAL**

It began out of the blue 19 years ago with a flash on my computer screen at work: a marriage proposal from a man I'd never met. This was way back before cyber-stalking was a worry. It went something like this: "I have \$40 in my pocket and I drive an old Pinto. Will you marry me? By the way, my name is Bruce." Of course, I accepted... and then introduced myself. After all, he lived on the opposite coast, what could be safer? Immediately, I realized Bruce had a mind like no one I'd ever

known: a wacky, lightning-quick wit and absolute brilliance. Oh, and he was also a very, very nice guy.

The instant messages soon morphed into phone calls, those long ones you have when you're in those early days of exploring a new relationship. During the first or maybe second phone call, Bruce dropped the bombshell: He was an alcoholic. "What was that you just said?"

I am a "normie". (Though few who know me would put my name and any form of the word "normal" in the same sentence.)

I'd known plenty of practicing alcoholics; heck, there were a bunch of them in my own family, but I had never been close to anyone who was in recovery. You mean you go to those meetings where you stand up and say, "My name is Bruce and I'm an alcoholic"? I couldn't see it. This was a man who was more disciplined in every other aspect of his life than I would ever be: exercise, diet, work, EVERYTHING. "Mv Name is

I knew embarrassingly little about alcoholism and AA and, frankly, didn't understand back then why someone with eight years of sobriety would need to go to several meetings each week. I mean, he'd quit drinking, right? He was over it! No longer hopping into his wooden barrel and sailing over Martini Falls.

In time, I learned you don't "get over" alcoholism, that it's a lifetime of living one day at a time. I also learned that there is tremendous power in a group and trying to white-knuckle sobriety alone was probably not a great idea for a whole lot of people.

Bruce and I are approaching our 10<sup>th</sup> wedding anniversary and I can honestly say the program I didn't really understand at first has truly been a blessing, not just for Bruce but for me. When I hear stories from Bruce about his drinking days, it's as though he's talking about someone I've never met. (The story about trying to order drive-thru fast food from a tree after driving into someone's front yard the middle of the night IS funny, but most of them are not.) I cannot conjure up an image of Bruce with a drink in his hand. And I know those who knew him back in the day cannot imagine him WITHOUT a drink in his hand. Nor can I imagine the behavior he has told me about from his past coming from the kind, compassionate man I quickly grew to love. He calls it nothing short of grace, a miracle.

#### Friend of Bill

In the network television newsroom where I worked, a woman sat not far from me. She was a writer and easily

twenty years my junior. Our interaction was pretty much limited to "Hi" and "Have a good weekend." But one day she approached me and asked if we could speak privately. She was clearly unsettled and anxious about something.



Once in my office, she said she had approached me because I seemed to her to be an understanding and compassionate person. In an attempt to keep things light, I asked her if that was just her way of saying my grey hair and wrinkles made her at least hope I was a good guy. She laughed but then added that she seriously had been watching how I dealt with other folks in the newsroom and had concluded that I was a person who listened well and could be trusted. I was not at all sure about that but figured: well, Cummings, you better listen well now and prove yourself worthy of some trust with this person.

In addition to her journalistic work, she was also an aspiring actor [this story unfolded in Los Angeles]. She'd been approached by a director and asked to go to dinner, ostensibly to talk about a script and a possible role. You can probably sense what's coming next...the only role this guy had in mind for the woman was as a sexual partner and while she was not naïve about how some of Hollywood's "finest" plied their craft, she was still badly jolted and deeply offended by the incident. She left the restaurant as calmly but quickly as she could, sure in her own mind that by rejecting this overbearing, arrogant man's advances, she had set her acting career back badly.

So we talked about what had happened and, in the course of the conversation, I, without thinking, began a sentence with a phrase we have all used so many times, "I remember being at a meeting once..." and then went on with the point I was trying to make. The woman's facial expression suddenly changed...she reached out and grabbed my arm and said, "Did you just say, 'I remember being at a meeting

once'?" I said that that was indeed what I had said. She replied, "Did you mean 'meeting' as in 'MEETING'?...as in AA meeting?" I quickly realized what I had done but felt completely comfortable telling this person that I was in the Fellowship. "Yes, indeed, 'meeting' as in 'AA meeting.' I've been sober a while and grateful

for that," I said. Her eyes began to fill with tears but her mouth was reaching for a smile. "I've been sober and in AA for about two years," she said and we hugged each other.

From then on my new friend...and Friend of Bill...talked every day. My work day ended just a short while before her work evening began so we were able to grab a couple of minutes late each

afternoon to talk. We were able to get to a few of the same meetings and to this day, though I retired two years ago and left Los Angeles for Bend, this wonderful Friend of Bill and I are in touch at least once a week either by email or phone. It is a sober friendship I treasure.

## TAKE FIVE ALIVE

#### **What Is An Informed Group Conscience?**

I have sat in AA meetings and witnessed some excited and spirited discussions on many subjects. What the subjects were are secondary to how they were handled within a group setting. Anecdotal evidence suggests that within any population there exist strong-willed individuals, perhaps more so in AA than the general public.

One of the goals in AA is a concerted effort toward humility. I for one, prior to entering the rooms of AA, had not the

slightest idea of what humility was – never mind made any attempt to attain it. I was taught, and believed, that pride, strong self will and independence of the help of others were desired states of mind and spirit. Fortunately I have come to believe that the practice of humility gives freedom



and blessings beyond my imaginings. AAs that enter into service with the idea that they will be placing themselves in a position of power, influence and prestige are soon surprised that the service structure, third legacy voting procedure and the concepts for world service effectively limit if not eliminate that illusion quickly.

The informed group conscience is another very effective tool to prevent our power drivers from exercising self will within or on the AA fellowship. The informed group conscience is described in the AA pamphlet **The AA Group...** where it all begins on the bottom of p. 26.

#### What is an Informed A.A. Group Conscience?

The group conscience is the collective conscience of the group membership and thus represents substantial unanimity on an issue

before definitive action is taken. This is achieved by the group members through the sharing of full information, individual points of view, and the practice of A.A. principles. To be fully informed requires a willingness to listen to minority opinions with an open mind.

On sensitive issues, the group works slowly- discouraging formal motions until a clear sense of its collective view emerges. Placing principles before personalities, the membership is wary of dominant

opinions. Its voice is heard when a well-informed group arrives at a decision. The result rests on more than a "yes" or "no" count-precisely because it is the spiritual expression of the group conscience. The term "informed group conscience" implies that pertinent information has been studied and all views have been heard before the group votes.

That about says it all, doesn't it? If a group follows these suggestions there is an excellent chance that The Truth/God's Will may be expressed by the group. If the practice of the group is found to be in error then it can be corrected through the exercise of A.A. Concept V for world service, a traditional "Right of Appeal"... I'll save that for another time.
